## **Corey Smith – Financial Report**

Corey Smith reports that while the year to date to previous year comparison is not favorable looking, at first glance, due mostly to the lack of business associated with snow, it is an apples to oranges comparison due to this year having many weddings booked as opposed to only a few last year

#### **Old Business**

- Judy Kinney states that ski area insurance funds may move from Village District to Rec fund.
  - Discussion postponed to November to better understand year end funds.
  - Waiting for Auditor to provide final report which is holding some long term projects, ie: tennis courts.
  - Motion made and unanimously approved to raise day pass cost to \$12 effective upon the new dues year in June.
  - Extra adult pass will stay at \$120

#### **New Business**

Long Term Planning

- Pools incurred extra expenses with repairing both indoor pools. Main pool crack repaired but persisted after pool filled. High pressure epoxy to be used by contractor.
- Ski area remodel, Foundation started. Water diversion system considered. Looking at moving water to right of lift shack. Neighbor advised and working with Corey Smith.
- Electric feeder to Snowbase Condos accidently cut during culvert work. Power company and
  DigSafe notified of accident. Working with Snowbase owners to change their power feed to come
  from Parker Rd and not through ski area parking lot. Details and costs are being investigated.
- Water system battery backup for Pegwood Rd water system being installed.

- Taylor Rd water pump improvements with an automatic switch for backup pumps.
- being quoted for installation this summer.

# Other

- Rowing machine repairs are still needed. Judy Kinney stated that the repairs should have been completed. Judy to investigate.
- Squat machine upgrade needed to install weight stop. Corey Smith to investigate.
