## Snow making

A petition with over 100 signatures was submitted to the board in support of snow making. Board after careful consideration of the pros and cons of snow making on the tow rope has decided to vote in favor of snow making on the tow rope at Campton Mtn for \$34,021.93. The funds for the purchase will be coming out of the CIF. An email vote was passed unanimously with one abstention by Art. Another vote was taken at the meeting and once again passed unanimously (by all board members preset) with Art abstaining.

Operational expenses for electricity, water, generator is to come from friends of Campton Mtn funds but there is a problem with the use of the fund at this time as it is needs to be registered as a nonprofit, we will need to file a 501c3.

Letter from a homeowner regarding Campton mtn read aloud Ticket price at Campton Mtn increased to \$12 day or night, \$20 for full day on the tow rope \$22 day or night, \$36 fill day for the full mtn Pic pass gets 20% off Season pass \$125 for estates residents only

## Rental policy:

Claire working on system to identify owners not complaint with NH laws for renting properties

Neighbors to please report violations or disturbance to the company through which the property is being rented. Board to discuss fine for violations

#### **Managers' report:**

Budget seems adequate at this time it does not appear that the WEA will require the tax offset form WV budget. Ski area offset depends on the season we have

Water system update: as part of planning for water system, RFQ for engineering firms to draft a plan for water system, reserve advisors for overall health and expected updates of facilities

Water engineers confirmed that there would be no impact on water supply and last year's level of snow making or even twice as much, water treatment improvement was a reporting violation, water is safe. Also trying to find all the leaks in the system and fix it.

Electrical system update: inadequate surge protection even at current levels of usage. Undersized for max load. For keeping up with the current usage and to add snow making an upgrade will be needed, 2 engineers evaluating the situation. This upgrade will be through the district.

Ski area update

Full load dynamic test for the ski lift in a couple of weeks, we purchased extra chairs, repairs made to upper lift shack, and plans underway to promote the ski area.

#### Tax rate:
